Revision of School Fees for Academic Session 2008-2009

1. No fee and funds upto VIIIth Class for both boys and girls
2. No tuition fee from girl students (Model & Non-Model)
3. SC/ST boys are also exempted from Tuition Fee
4. Funds will be charged half from SC/ST students both boys and girls
5. Smart sections students will be charged Rs. 150/- per month in addition to the normal fees and funds
6. No tuition fee will be charged from all boys students belonging to Muslims / Christians / OBC, handicapped, Freedom Fighters, Ex-serviceman, Widows, divorces having family income below the limit of 1.5 lacs per year
7. Boys students of all rural schools will also be exempted from half tuition fee if they provide a proof of residence and of income limit below Rs. 1.5 lacs per annum.
8. These rates of Fee / Funds shall be valid for minimum three years

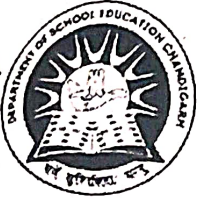



Subject: Govt. School Amalgamated Fund Rules- 2024

1. The Govt. Schools Amalgamated Fund Rules 2024 have been framed with the approval of Hon'ble Administrator and has been issued under No. DSE/UT/A3/2024/3669 dated 04.07.2024.
2. For administrative convenience, these Govt. Schools Amalgamated Fund Rules 2024 shall come into force on and from the 1st day of August, 2024.
3. Before the said Govt. Schools Amalgamated Fund Rules 2024 are implemented, the following checks, must be applied.
 - (a) DEO/ Principal / Heads of Govt. Schools shall ensure that all cashbooks of various funds maintained at their level of DEO/ Schools are completed in all respects and duly signed by the concerned Accountant / Superintendent / Head / Principals of Govt. Schools/ DEO as the case may be.
 - (b) Thereafter, all concerned shall forward the cashbook to the S.O, posted in DEO office, UT, Chandigarh for verification of closing balance as on 31.07.2024
4. The verified closing balance of cashbooks of all funds of Govt. High/ Model High /Sr. Sec./ Model Sr. Sec. Schools as on 31st July, 2024 shall be brought forward in the NIC fee portal/online cash book of the Govt. Schools / DEO, UT Chandigarh.
5. All concerned must ensure that from 1.8.2024 onwards, only online monetary transaction will be made at the level of DEO/ Govt. Schools. Manually/ monetary cash transactions are prohibited.
6. Online Challans on account of tuition fee if any, as well as funds deposited by the students through online portal will be directly generated at level of DEO / Govt. Schools from 1st August, 2024 onwards.
7. On the basis of system generated challans, cashbook of student fund will be maintained proper reconciliation at the level of DEO/ DDO-cum-Principals/ Heads of Govt. Schools. Proper reconciliation in respect of tuition fee / Govt. School Amalgamated Fund Rules will be made by the DDO of Govt. Schools / DEO.
8. Concerned DDO will be responsible for all financial transaction as referred to above.

Noncompliance of these instructions will be viewed seriously.
